An Act further to amend the Indian Treasure-trove Act,
1878, in its application to the ³State of Tamil Nadu.

WHEREAS it is expedient further to amend the Indian
Treasure-trove Act, 1878, in its application to the ³[State
of Tamil Nadu], for the purposes hereinafter appearing;
It is hereby enacted as follows :—

1. (1) This Act may be called the Indian Treasure-trove ^{Short title}
(¹[Tamil Nadu] Amendment) Act, 1949. ^{and extent.}

(2) It extends to the whole of the ⁴[State of Tamil Nadu].

2. Section 4 of the Indian Treasure-trove Act, 1878 ^{Amendment}
(hereinafter referred to as the said Act), shall be renumbered ^{of section 4,}
as sub-section (1) of section 4, and after that sub-section, ^{Central Act}
the following sub-section shall be added, namely :— ^{VI of 1878.}

“(2) The owner of the place in which the treasure is
found, if he is not the finder, and the occupier of such
place, if he is neither the finder nor the owner, shall also
give notice in writing to the Collector specifying the parti-
culars referred to in clauses (a), (b) and (c) of sub-section
(1), before the expiry of two months from the date on
which the owner or the occupier, as the case may be,
becomes aware of the finding of the treasure.”

Amendment of section 5, Central Act VI of 1878. 3. In section 5 of the said Act, for the words, figure, and brackets "On receiving a notice under section 4, the Collector shall, after making such enquiry (if any) as he thinks fit, take the following steps (namely:—", the following shall be substituted, namely :—..

"The Collector shall on receipt of a notice under section 4, and may, on receipt of information in any other manner that treasure has been found in any place, take the following steps, after making such enquiry (if any) as he thinks fit to make :—"

Addition of new section 22 of Central Act VI of 1978. 4. After section 21 of the said Act, the following section shall be added, namely :—

Penalty on owner or occupier who fails to give notice under section 4. "22. If the owner or occupier of the place in which any treasure is found, being aware of the finding thereof, fails to give notice as required by section 4, sub-section (2), he shall be punishable with imprisonment which may extend to six months, or with fine, or with both."
