THE OPIUM AND DANGEROUS DRUGS ('[TAMIL NADUI AMENDMENT) ACT, 1947.]

(Received the assent of the Governor-General on the 23rd January 1948; first published in the Fort St. George Gazette on the 3rd February 1948.)

An Act further to amend the Opium Act, 1878, and the Dangerous Drugs Act, 1930, in their application to the ³[State of Tamil Nadu].

WHEREAS it is expedient further to amend the Centra Opium Act, 1878, and the Dangerous Drugs Act, Act I 1878. 1930, in their application to the ³ State of Tamil Centre Nadul, for the purpose hereinaster appearing; It is Act II hereby enacted as follows:---

Short title and extent.

- 1. (1) This Act may be called the Opium and Dangerous Drugs (1 Tamil Nadu] Amendment) Act,
- (2) It extends to the whole of the 4 State of Tamil Nadul.

Amendment of section 14. Central Act I of 1878 and Section 23. Central Act II of 1930.

2. In section 14 of the Opium Act, 1878, and Control Act 10 section 23, sub-section (1) of the Dangerous Drugs 1878. Act, 1930 (which give certain powers of entry, search, Central seizure, etc., to officers of some departments), after the Act II word "Excise", the word "Prohibition", and after the word "peon", the word "guard", shall be inserted.

An Act further to amend the Dangerous Drugs Act, 1930 in its application to the 8[State of Tamil Nadu]

Whereas it is expedient further to amend the Central Act II of 1930. Dangerous Drugs Act, 1930, in its application to the ⁸[State of Tamil Nadu] for the purpose hereinafter appearing; It is hereby enacted as follows:-

(1) This Act may be called the Dangerous Short title and extent. [Tamil Nadu] Amendment Act, 1950.

An Act further to amend the Opium Act, 1878, in its application to the ³[State of Tamil Nadu].

WHEREAS it is expedient further to amend the Opium Central ^ct, 1878, in its application to the ³[State of Tamil Nadu] Act 1 of for the purposes hereinafter appearing; It is hereby ¹⁸⁷⁸. enacted as follows:

- 1. (1) This Act may be called the Opium [Tamil Nadu] Short title and extent. Amendment Act, 1951.

2. In section 9 of the Opium Act, 1878 (hereinafter Central Amendment of section 9, referreed to as the said Act), for the words "imprisonment Act 1 of Central Act 1 for a term which may extend to one year, or with fine 1878. of 1878. which may exetnd to one thousand rupees, or with both", the words "imprisonment for a term which may extend to two years, or with fine which may extend to two thousand rupees, or with both" shall be substituted.

Amendment 3. In section 20 of the said Act, after the words of section 20, "nearest police-station", the words, figures and letter of 1878. "or to the nearest officer of the Prohibition Department empowered under section 20-A" shall be inserted.
