[THE '[TAMIL NADU] REPEALING AND AMENDING ACT, 1952.]

(Received the assent of the Governor on the 12th December 1952; first published in the Fort. St. George Gazette on the 17th December 1952.)

An Act to repeal certain enactments and to amend certain other enactments

WHEREAS it is expedient that the enactments specified in the First Schedule which are spent or have otherwise become unnecessary, or have ceased to be in force otherwise than by expressed specific repeal, should be expressly and specifically repealed ;

AND WHEREAS it is also expedient that certain amendments should be made in the enactments specified in the second Schedule ; It is hereby enacted as follows:—

Short titles 1. This Act may be called the ¹[Tamil Nadu] Repealing and Amending Act, 1952.

Repeal of 2. The enactments specified in the First Schedule certain enact- are hereby repealed to the extent mentioned in the fourth ments. column thereof.

Amen at 3. (1) The enactments specified in the Second Schedule of certaindme are hereby amended to the extent and in the manner enactments. mentioned in the fourth column thereof.

> (2) The amendment to the '[Tamil Nadu] Shops and Establishments Act, 1947 ('[Tamil Nadu] Act XXXVI of 1947), specified in the Second Schedule shall be deemed to have come into force on the 1st day of April 1951.

Savings. 4. The repeal by this Act of any enactment shall not affect any other enactment in which the repealed enactment has been applied, incorporated or referred to 1
